PRIVACY ACT STATEMENT

AUTHORITY: 10 U.S.C. § 5041, Headquarters U.S. Marine Corps, and E.O. 9397 (EDIPI)

PRINCIPAL PURPOSE: To collect information necessary to assign the best qualified Marines to serve as curriculum developers or Staff Noncommissioned Officer (SNCO) Academy faculty advisors.

ROUTINE USE: Information collected on this form will be shared with the prospective applicant's chain of command, the CEME Directors and Manpower Management Enlisted Assignments (MMEA).

RETENTION: CEME forms are used and properly archived according to Marine Corps orders pertaining to the appropriate storage of records.

DISCLOSURE: Providing information on this form is voluntary. However, failure on your part to answer all questions, or any misrepresentation (by omission, concealment, or by misleading or partial answers) may result in your ineligibility for assignment.

Purpose: To ensure Marines applying to become curriculum developers or SNCO Academy faculty advisors are best qualified.

Information: CEME curriculum developer and faculty advisor duties are very demanding and rewarding assignments. Curriculum developers are responsible for developing curriculum that provides formal education to the enlisted force through professional military education (PME). Faculty advisors are directly responsible for educating, mentoring, and preparing Marines for assignments of increased responsibility. After selection, Marines serving as faculty advisors must successfully complete the Faculty Advisor Course before they will teach at a Staff Noncommissioned Officer Academy. In order to ensure CEME is equipped with the best cadre possible, it is necessary that parent commands thoroughly screen applicants accordingly.

Action: The completed screening checklist must be routed through the Marine's unit Career Planner to the Enlisted Assignment Branch (MMEA).
