Subj: CONTROL OF ALCOHOLIC BEVERAGES

- 1. <u>Purpose</u>. To promulgate policy, procedures, and information concerning the consumption of alcoholic beverages within the geographical confines of Education Command and Marine Corps University Campus, Quantico pursuant to the reference.
- 2. <u>Definition</u>. The term "alcoholic beverages," as referred to in this policy includes all beer, wines, ciders, and distilled spirits.

3. Information

a. <u>Alcohol Consumption</u>. Commanders and tenant activities with general officers in charge are authorized to grant approval to introduce, possess, and consume alcoholic beverages within their respective schools, spaces, or areas for special events and occasions on an ad hoc and infrequent basis.

b. Prohibition

- (1) Minors. Persons under 21 years of age will not introduce, purchase, possess, or consume alcoholic beverages while aboard base.
- (2) <u>Alcoholic Beverages in Motor Vehicles</u>. An open container of any alcoholic beverage in the passenger area of a privately-owned vehicle is prohibited. A can or bottle is considered open if the seal is broken.
- 4. <u>Alcoholic Beverage Consumption Requests</u>. Directors who desire to consume alcoholic beverages within their school spaces or associated areas shall submit a written request to the President, Marine Corps University, using the format contained in enclosure (1).

5. Action. Directors, ensure that all members of their schools or departments are aware of the contents of this policy and applicable reference.
